Release Letter Authorizing the Use of Recipes by Nutricia North America Inc.
(Hereinafter the "**Release Letter**")

Context - I, the undersigned, acknowledge the following: (1) Nutricia North America Inc. (hereinafter "**Nutricia**") has created the template for an empty booklet to be filled out with recipes (hereinafter the "**Empty Booklet**"); (2) The Empty Booklet is being offered to PKU and allied disorders patients that are members of the Canadian PKU and Allied Disorders Inc. Association (hereinafter the "**Association**") (hereinafter individually a "**Patient**" and collectively the "**Patients**") and, ; (3) The Association and Nutricia wish to gather recipes from Patients, produce a filled-out version of the Empty Booklet, containing said recipes from Patients (hereinafter the "**Filled-Out Booklet**") and distribute the Filled-Out Booklet to the public in both physical and digital formats.

Creation of the Recipe and related Work Products - I, the undersigned, hereby confirm that I have created the recipe attached hereto as Exhibit A and incorporated herein by reference (hereinafter the "**Recipe**"), as well as any and all Work Products related to the Recipe. For the purpose hereof, "**Work Products**" shall mean all of the technical information, computer or other apparatus programs, specifications, drawings, records, documentation, reports, materials, concepts, plans, inventions, discoveries or adaptations, creative works, photographs, video, data, trade names or trademarks, works of authorship or other creative works, written, oral or otherwise expressed, developed, conceived or acquired by me in connection with the Recipe, and derivative works thereunder as well as any rights acquired by me in connection with the Recipe.

Transfer and Assignment of Ownership - I, the undersigned, hereby transfer and assign to Nutricia the ownership of and all right, title and interest in the Recipe and related Work Products, including any copyright, trademark, trade secret, patent or other proprietary rights, and the right to sublicense or transfer any and all rights assigned under this Release Letter to third parties in perpetuity. I hereby agree to assist and cooperate with Nutricia and execute all appropriate documents, to perfect Nutricia's right in the Recipe and related Work Product.

Compensation – I, the undersigned, hereby acknowledge and agree that no remuneration, whether monetary or of any other kind, shall be offered to me as compensation for the transfer and assignment of the ownership and right to use and distribute the Recipe and related Work Products, as envisioned herein. Notwithstanding the preceding, I hereby acknowledge and agree to be credited for the Recipe and related Work Products with a mention of my name as the creator of the Recipe and related Work Products.

Use and Distribution - I, the undersigned, hereby acknowledge and accept that Nutricia shall have the right to use the Recipe and related Work Products for all purposes and in all formats, without any prior notice or consent. I further authorize Nutricia to distribute now or at any time in the future, all such Recipe and related Work Products, in any manner or form, including but not limited to distribution or publication for advertising, online (including internal and external websites and social media sites), trade or publicity in magazines, newspapers, television, radio, public relations documents or general information to the public. I agree that no material produced hereunder, including without limitation the Filled-Out Booklets, such copy, graphic or pictorial matter, needs to be submitted to me for any approval, and Nutricia shall be without liability for any editing, amending, distortion, blurring, alteration or illusionary effect resulting from the use, publication and distribution of my Recipe and Related Work Products and my picture, portrait or likeness.

Release - I hereby release and forever discharge Nutricia and the Association, and their respective successors, heirs and assigns from any and all causes of action, whatsoever, in law and in equity including any right or claim to any proceeds or sums of monies generated or received by Nutricia by reason of the use, sale or dissemination of the Recipe and related Work Products described herein.

This document is governed by the provincial and federal laws of Canada which may be applicable, and its interpretation is subject to these laws.
